1. Summary

1.1 In June 2018, Trysor undertook a photographic survey at Cwmclyd Farmstead, at SN8914762235, to the northern side of the minor road from Nantgwyllt Church to Claerwen Dam in the Claerwen Valley, Rhayader. This survey was undertaken for the Elan Valley Trust, in advance of the renovation and conversion of the disused farmstead buildings into bunkhouse accommodation, along with the installation of package treatment plant and improvements to the existing access, planning application P/2017/0573 (Powys).

1.2 The modification of the farmstead buildings will see the retention of some external features but the interiors of the buildings will be replaced.

3. Introduction

3.1 The Elan Valley Trust, Elan Estate Office, Elan Village, Rhayader LD6 5HP, commissioned Trysor heritage consultants to write a Written Scheme of Investigation relating to condition 3 on planning application number P/2017/0573 (Powys).

3.2 Trysor produced a written scheme of investigation for a Level 2 building record, see Appendix A which was approved by the archaeological advisors to the local planning authority.

3.3 The project has been identified as 2018/619 in Trysor records and given a site code CYD2018.

4. The Development




Figure 1: Location of Cwmclyd farmstead.

4.1 The development consists of alterations to the disused farmstead buildings at Cwmclyd, in the Elan Valley, which will be converted into bunkhouse accommodation, with improved services and access, see Figure 1.




Figure 2: Layout of Cwmclyd

4.2 The works will consist of the full conversion of the farmhouse and cowshed, stable and cartshed, and barn within the farmstead complex, for use as bunkhouse accommodation, see Figure 2. The privy will be stabilised. A new sewage treatment plant will be installed and the access to the farmstead will be improved. This application does not include the "Bungalow", the 20th century farmhouse which is believed to be a relocated dam-builders' hut dating to the construction of the earlier dams in the Elan Valley.

5. Conditions on the consent

5.1 In granting approval for the application, the Local Planning Authority imposed a condition on the consent; the condition specifies the actions necessary to mitigate the impact of the development on the built resource;

"No development shall take place until a programme of building recording and analysis, equivalent to an Historic England Level 2 building survey, has been secured and implemented, in accordance with a brief issued by the local planning authority and a written scheme of investigation which has been submitted and approved in writing by the local planning authority. The programme of building analysis and recording must meet the standards laid down by the Chartered Institute for Archaeologists in their Standard and Guidance for the archaeological investigation and recording of standing buildings or structures. A copy of the resulting report should be submitted to the Local Planning Authority and the Development Control Archaeologist, Clwyd-Powys Archaeological Trust (41 Broad Street, Welshpool, Powys, SY21 7RR Email: markwalters@cpat.org.uk Tel: 01938 553670). After approval by the Local Planning Authority, a copy of the report and resulting archive should also be sent to the Historic Environment Record Officer, Clwyd-Powys Archaeological Trust for inclusion in the regional Historic Environment Record."

6. Methodology

6.1 On June 8th, 2018, Trysor visited the farmstead and took a series of photographs showing internal and external views and features of the building group and the individual buildings within the group.

6.2 A Level 2 record of each building was made to record their interior and exterior features. Historic England's *Understanding Historic Buildings: A guide to good recording practice* was used for guidance. This defines a Level 2 record as;

"....as a **descriptive record**, made in similar circumstances to Level 1 but when more information is needed. It may be made of a building which is judged not to require a more detailed record, or it may serve to gather data for a wider project. Both the exterior and interior of the building will be seen, described and photographed. The examination of the building will produce an analysis of its development and use and the record will include the conclusions reached, but it will not discuss in detail the evidence on which this analysis is based. A plan and sometimes other drawings may be made but the drawn record will normally not be comprehensive and may be tailored to the scope of a wider project." (Historic England, 2016, p,26).

7. Historical and Archaeological Overview

7.1 The buildings of the Cwmclyd Farmstead group include the farmhouse and attached cowshed, a barn, a cartshed and attached stable, and a small privy. Just to the west of the farm buildings is a wooden hut which was moved to the farm in the early 20th century and used for a period as the farmhouse. This is known as the Dam-builders' Hut, as it believed to have been originally erected at the Elan reservoir complex and used by workers engaged on the dam scheme. The Dam-builder's Hut is not included in this report, but is subject to a separate Level 2 Building Recording report (Trysor, forthcoming).

7.2 The farmstead is recorded in records held by both the Royal Commission on the Historic and Ancient Monuments of Wales (RCAHMW) and the Clwyd-Powys Archaeological Trust (CPAT).

7.2.1 The farmstead is recorded in the National Monuments Record as NPRN 81151. There is also a separate record in the NMR for the Cow Shed at Cwmclyd, NPRN 22748, which refers to the house and cowshed. The buildings were surveyed by the RCAHMW in 1988, photographed in 1989 and a measured sketch plan of the house and cowshed made in 1990. The originals of these records are held at the NMR archives in Aberystwyth.

7.2.2 The farmstead is recorded in the regional Historic Environment Record, held by CPAT under as Primary Reference Number 44800. The constituent buildings are also individually recorded in the HER. The house and cowshed is recorded as a longhouse, PRN 36882. The cartshed and stable is recorded as PRN 36881, the barn as PRN 48767 and the privy as PRN 48769. The 20th century farmhouse (Dam-builders' Hut) is recorded as a house (PRN 48768).

7.2.3 The buildings within the farmstead are not Listed Buildings.

7.3 The origins of Cwmclyd farm are not clear. Both the RCAHMW and CPAT consider the complex to be of post-medieval date, with the RCAHMW describe the house as being a "cottage-farmhouse" dating to c.1800. Although CPAT have a record for the house as a "Post-medieval longhouse", the dwelling is not in the medieval longhouse tradition but is an example of a post-medieval tradition of attaching a byre to the dwelling. There is no evidence of any direct, internal, connection between the dwelling and the byre in the house and cowshed at Cwmclyd.

7.4 A document dating to 1848 and held in the D.T.M Jones collection at the National Library of Wales refers to the farmstead as "*a messuage and lands called Tyddyn a Thyr Cwmclyd Gwair y Cefn bordering on the River Claerwen…*" The description of a holding as a "tyddyn" or

tenement is interesting, as it implies that Cwmclyd may well have origins in earlier post-medieval times, or even late medieval times.

7.5 In terms of physical appearance, the buildings within the farmstead complex are all stone-built, with wooden door and window frames. Each building has the appearance of being of later post-medieval date, being of rubble build. Doors and window shutters are painted in green, with frames, lintels, bargeboards and fascias painted black, reflecting the Elan Valley Estate colours.

7.5.1 It is evident that some work has been undertaken to improve the condition of the buildings in recent times. Some walls have been repaired and repointed, for example. When the buildings were surveyed by the RCAHMW in the late 20th century, they noted that tin sheets covered the roof of the house and cowshed, but by 2017 the roofs of each building were of slate, with largely modern roofing timbers.

7.6 The farmhouse and attached cowshed (see Plates 9, 13 & 37-108 in Appendix B) is described by the RCAHMW in their 1988 survey as follows;

"Rubble-built house-and-byre, probably dating from the late C18, now converted to a farm store with the chimney removed. The house was originally of end-chimney lobby-entry plan and of one and-a-half storeys. Beyond the kitchen are two small rooms, probably cold parlour and dairy, divided by a plank partition. The loft is reached by a tight stone fireplace stair. The trusses are simple pegged A-frames. The byre is down-hill sited beyond the parlour/service end of the house. There is tethering for twelve cows – two rows of double ties either side of a central feeding passage."

In 1990 a further visited was made to the farm by the RCAHMW, and the following additional note added to the record;

"Lobby-entry end-chimney house with cowhouse in range. Stone stair by fireplace, gable end roof truss; transverse beams; lath and plaster partitions... Cottage farmhouse of c.1800 now converted to farm store."

7.6.1 The building was described in similar terms by CPAT as part of a Tir Gofal survey in 2004. This survey notes that the building was wellmaintained and under a slate roof, which suggests that the repairs to the building had been undertaken by this date. CPAT also noted that there was a cast-iron range in the house, presumably in the fireplace, which was not present when visited by Trysor in 2018.

7.6.2 The 2018 survey carried out by Trysor found no evidence to contradict the interpretation of the RCAHMW's 1988 survey in terms of

dating the building. A number of additional points are worthy of mention however. Overall the building measures approximately 14.5 metres north northwest to south southeast by 6.50 metres. The cowshed or byre occupies the northern 7.20 metres.

7.6.3 The southeastern corner of the building, at the house end, is terraced into the slope (see Plates 40 & 41). At this corner there is the scar of an infilled doorway, with a sawn timber lintel still in place above (see Plate 91). From the interior, this looks like a simple, blocked-up doorway. From the outside, the southern part of this "door" is however buried in the slope (see Plate 43). If this was a doorway, it is evident that earth has either been piled around the southeastern corner of the building after it was constructed or has slumped forward. This is the doorway identified on the RCAHMW plan of 1990 as a "blocked original door".

7.6.4 The farmhouse and cowshed building is also terraced into the slope along its eastern side, where a 1.25 metre-wide pathway has been created to give access to the dairy and cowshed doors (see Plate 39). The edge of the cut into the slope along this side is revetted with stone.

7.6.5 The stairs which lead from the kitchen up to the loft at the southern end of the building also lead to a doorway out through the upper part of the gable wall, emerging at ground level due to the terracing of the building into the slope at this end (see Plate 40).

7.6.6 The RCAHMW were correct to state that the original chimney had been removed from the house, but do not mention that a replacement, red-brick, chimney had been inserted at some point (see Plates 40, 44 & 108). This chimney would probably have served the cast-iron range which formerly stood in the fireplace.

7.6.7 The roof of the building has clearly undergone significant repair to the extent that most of the timberwork is now of modern date. The slates in the roof have been attached with wooden pegs, but on to modern timber.

7.6.8 Historic Ordnance Survey maps show that a benchmark was carved into the northern gable end of the farmhouse and cowshed building, marking an altitude of 1021.8 feet. This benchmark is clearly visible near the bottom of the wall (it can be seen left of centre in Plate 37).




Figure 3: The 1820 Ordnance Survey Original Surveyors Drawings show Cwmclyd. Only the area to the west of the small stream which flows through the property is shown as being enclosed. The map is indistinct but the farmhouse may just be visible above the "y" in the placename and another building may be visible above the "I".

7.7 **The stable and cartshed building** stands to the east of the house and cowshed, on slightly higher ground (see Plates 2-12 & 14-36 in Appendix B). It is not recognisable on maps, including the 1840 tithe map, before the 1888 1:2500 scale Ordnance Survey map, which may *Cwmclyd Farmstead Level 2 Building Recording, Planning Application P/2017/0573 (Powys), June 2018*

indicate that it is of mid-19th century origin (see Figures 2, 3 & 4 below). There are no architectural details which suggest the building to be of pre-19th century date.

7.7.1 This is also a rubble-built building but large quoinstones, under a slate roof. The roof is in good condition, despite the slippage of some slates along its eastern side. It was not possible to enter the hayloft, therefore the timbers supporting the roof were not examined. The floor of the hayloft also forms the ceiling of the stable and cartshed below, from where only modern beams and planked flooring are visible, suggesting that the roof has been rebuilt in modern times in the same fashion as those of the neighbouring barn and house.

7.7.2 Overall the building measures approximately 8.70 metres north northwest to south southeast by 5.20 metres. The northern half of the building consists of the cartshed, with a wide entrance in the northern gable wall. A small doorway above this entrance gave access to the hayloft in the roof-space above the cartshed and stable (see Plate 12). The floor of the cartshed was hidden beneath a thick layer of dung and could not be examined.

7.7.3 The stable occupies the southern half of the building. This portion is accessed through a single doorway in the west-facing wall (see Plate 2) and there is a small, shuttered window to the southern side of the doorway. Internally, there are two wooden feeding stalls against the eastern wall (see Plates 22-27), separated by a wooden partition. Above the feeders are gaps in the ceiling to allow hay to be thrown down from the hayloft above. The floor of the stable is obscured by a thick layer of dung, although this was thin enough inside the doorway to be scraped away to reveal a cobbled floor below (see Plate 35).

7.7.4 A small, stone-built, lean-to stood against the southern gable wall (see Plates 3, 6, 7, 10 & 11). This was roofless and in a ruinous condition. It had been built on a terrace which had been cut into the rising slope to the south, with its southern wall therefore acting as a revetment wall (see Plate 36). This lean-to was evidently built at the same time as the main building, as the timber lintel over the door in its western side extends into the fabric of the stable.

7.8 **The barn** stands to the west of the stream which runs through the farmyard area at Cwmclyd. As with the stable and cartshed, the barn is not recognisable on maps earlier that the 1888 1:2500 scale Ordnance Survey map, which shows an L-shaped building in the same position, or comparable layout to that seen today. The 1840 tithe map shows a similar building in approximately the same area, but on a different alignment. The accuracy of the tithe map cannot be verified, therefore it is not known if the building shown is the same barn or not. It is possible




Figure 5: The 1840 parish tithe map shows the farm in more detail, but neither of the two buildings shown are recognisable in the present layout of the farm buildings. The L-shaped building to the left may correspond with the L-shaped barn shown on the 1888 Ordnance Survey map, although on this map it is on a different alignment.

that the present structure is of mid- 19^{th} century origin (see Figures 3, 4 & 5 below) as there are no architectural details which suggest the building to be of pre- 19^{th} century date.

7.8.1 The barn is a rubble built structure which has undergone repair and re-roofing in modern times (see Plates 115 and 117-136). Overall it measures approximately 11 metres by 5.5 metres. The interior walls have been repointed and the roof timbers are all of modern date (see Plate 136). A modern concrete slab covers the central third of the floor, with an earth floor visible at the northern and southern ends of the building. The original flooring would appear to have been removed, however. The repair of the building has left few architectural features of note, which makes dating difficult. Two slit windows are seen in the western wall (see Plates 124, 126 & 127) and a single slit window is found in the southern end of the eastern wall (see Plate 130). There is a single doorway at the northern end of the same wall (see Plate 119, 120, 131, 132).

7.8.2 A lean-to shed stands against the southern end of the eastern wall of the barn (see Plates 1, 9, 121 & 122). Overall this measures approximately 4.3 metres north northwest to south southeast by 2.6 metres. This is a 20th century structure, built of machine-sawn timber and clad with corrugated steel sheets. Its northern side was left open.

7.9 **The privy** stands to the west of the farmhouse and cowshed building (see Plates 109 -114). This is a small, rubble-built building, under a slate roof, which appears to be relatively unchanged. The original toilet is still in place, set into a wooden box. A single door gives access through the northern side. The privy does not appear on any historic mapping, including the 1905 1:2500 scale Ordnance Survey map, and may therefore be of early 20th century date.




Figure 6: The 1888 1:2500 scale Ordnance Survey map shows the present barn, house/cowshed and stable. The privy and Dam-builders' Hut are not shown. The Dam-builders' Hut was added c.1905 and was used as the farmhouse during the early 20th century.




Figure 7: The 1905 1:2500 scale Ordnance Survey map also shows Cwmclyd without the Dam-builders' Hut and privy, although it seems likely that both must have been added around this time. The Hut has the date 1905 painted on the glass of the front door.




Figure 8: Overview of Cwmclyd showing the location of photographs 001, 004, 006-009, 013, 037-039, 041-044, 109-114, 116-118




Figure 9: Location of photographs on ground floor of the house and cowshed, Photographs 045 to 102




Figure 10: Location of photographs within loft in the house and cowshed. Photographs 040, 054-055, 104-108.




Figure 11: Location of photographs of the cartshed and stable, Photographs 002-003, 005, 010-012, 014-022, 025-026, 028-036




Figure 12: Location of photographs of the barn. Photographs 115, 117-136

1. Introduction

1.1 The Elan Valley Trust, Elan Estate Office, Elan Village, Rhayader LD6 5HP, has commissioned Trysor heritage consultants to write a specification relating to condition 3, planning application number: P/2017/0573 (Powys).

1.2 The development is Cwmclyd at SN8914762235, to the northern side of the minor road from Nantgwyllt Church to Claerwen Dam in the Claerwen Valley, Rhayader. It is part of Elan Links funded by the Heritage Lottery Fund.




Figure 1: Location of the Cwmclyd farmstead



2. Objective of the Written Scheme of Investigation

2.1 The objective of this specification is to specify the method to be used for the Level 2 Building Recording.

3. The development

3.1 The development consists of the renovation and conversion of disused farmstead and buildings to bunkhouse accommodation, along with the installation of package treatment plant and improvements to the existing access.

3.2 The buildings within the development scheme consist of a longhouse, barn, cartshed and privy. The barn will be converted into a kitchen and dining area and a bedroom, the longhouse and carthouse will be made suitable for bunkhouse-style sleeping accommodation, and the privy will be stablised.

4. Conditions on the listed building consent

4.1 In granting approval for the application, the Local Planning Authority imposed conditions on the consent. Condition 6 specifies an action necessary to mitigate the impact of the development on the historic environment.

No development shall take place until a programme of building recording and analysis, equivalent to an Historic England Level 2 building survey, has been secured and implemented, in accordance with a brief issued by the local planning authority and a written scheme of investigation which has been submitted and approved in writing by the local planning authority. The programme of building analysis and recording must meet the standards laid down by the Chartered Institute for Archaeologists in their Standard and Guidance for the archaeological investigation and recording of standing buildings or structures. A copy of the resulting report should be submitted to the Local Planning Authority and the Development Control Archaeologist, Clwyd-Powys Archaeological Trust (41 Broad Street, Welshpool, Powys, SY21 7RR Email: markwalters@cpat.org.uk Tel: 01938 553670). After approval by the Local Planning Authority, a copy of the report and resulting archive should also be sent to the Historic Environment Record Officer, Clwyd-Powys Archaeological Trust for inclusion in the regional Historic Environment Record.

5. Nature of the archaeological resource

5.1 In correspondence dated 5th June 2017, the Development Control Officer at Clwyd Powys Archaeological Trust who advise the LPA on matters relating to the historic environment stated that the former farmhouse and its outbuildings were recorded in the regional Historic Environment Record (CPAT, 2017)

5.2 A Heritage at Risk survey for the Elan Valley Trust undertaken as part of documentation for the successful Heritage Lottery Fund application recorded the four structures from available evidence without a field visit (Trysor, 2016, Heritage At Risk)

6. Scope of Work

6.1 Historic England's *Understanding Historic Buildings: A guide to good recording practice* was used to write this Written Scheme of Investigation. They define a Level 2 record as

"....as a **descriptive record**, made in similar circumstances to Level 1 but when more information is needed. It may be made of a building which is judged not to require a more detailed record, or it may serve to gather data for a wider project. Both the exterior and interior of the building will be seen, described and photographed. The examination of the building will produce an analysis of its development and use and the record will include the conclusions reached, but it will not discuss in detail the evidence on which this analysis is based. A plan and sometimes other drawings may be made but the drawn record will normally not be comprehensive and may be tailored to the scope of a wider project"

6.2 A Level 2 record of the buildings will be made to record the interior and exteriors of the building (Historic England, 2016, p. 26) focussing on the photographic record with a written analysis. The photographic record of the buildings will be made to record the interior and exteriors of the outbuilding and any interesting features, doors and windows.

7. Methodology

7.1 The Level II Building Recording will be carried out in accordance with this specification, which has been written following guidance from Clwyd Powys Archaeological Trust (CPAT, Undated), Historic England (2016) and the Chartered Institute for Archaeologists (CIfA, 2014a).

7.2 A two-person team will take high resolution, colour, digital photographs using a 16M pixel camera. A written record will be made on site of the photographs taken. Appropriate photographic scales will be used.

7.3 They will photograph and record accessible external and internal faces of the building, as well as detailed shots of any interesting features of the building. A suitable scale will be used in the photographs, and the location and direction of each photograph recorded.

7.4 The applicants' existing plan and evaluation drawings of the building will be used in order to record the location and direction of photographs. Any additional features not already drawn will be added to the existing drawings.

7.5 A written analysis will be provided.














